



# **Objections to Voting Precinct Consolidation voiced at BOC meeting**



This map of Randolph County shows the proposed Voting Precincts of Cuthbert and Shellman, created by consolidating the current nine precincts into the two shown on the map. Randolph County Board of Elections and Registration is proposing the consolidation and will be holding public hearings this week.

The Board of Commissioners (BOC) met for their regular monthly meeting at 8 a.m. on Tues., Aug 14. Citizens comments were first on the agenda with Bobby Jenkins coming to the podium to voice opposition to the Proposed Closing of Voting Precincts in the County. Jenkins, chair of the Randolph County Democratic Committee, present-

ed a list of objections to the BOC. He also criticized the current two-member Randolph County Board of Elections and Registration (one-member (RCBER) short awaiting Cuthbert's appointment) as to qualifying Sunny Ghotra as a candidate in the recent District 5 Board of Education seat, questioning whether Ghotra met the residency requirement. Jenkins yielded

part of his allotted time to Candidate Joyce Barlow (D) who is seeking the seat of State Representative in the upcoming November election. Barlow spoke in support of Jenkins' objections.

BOC had some discussion on the Voting Precinct Consolidation at which time Todd Black, director RCBER, stepped to the podium to answer a few questions. It was mentioned by

a commissioner that many people early vote; Black stated there are 21 days of early voting before an election. During this time several in the audience were out of order, loudly stating their disapproval of the Proposed Consolidation of Polling Precincts. ### **Voter Suppression in Randolph County**

### Dear Editor:

Voter Suppression is an attempt to influence the outcome of an election by preventing, confusing, or discouraging specific groups of people from voting. Randolph County is planning to close 7 of the 9 voting places throughout the county. This action would leave only 2 voting places in the county, 1 in Shellman and 1 in Cuthbert.

This proposal is unfair because: 1) it creates a hardship on elderly and poor voters who will have to travel farther to vote; 2) this decision was made by a 2 member Board of Elections and Registration (1 person shy of a dictatorship); 3) no articles appeared in the local papers to alert citizens of the proposed changes; 4) this change is being proposed in the middle of the election cycle. Voters went one place in the Primary but will have to vote in another place for the General Election in November, which will lead to confusion. Up to 40% of the voters will be affected; 5) Georgia law 21-2-262 states in part that consolidation of precincts should promote the convenience of voters and the public interests. This plan would do the opposite.

The right to vote is sacred and must be treasured. Many gave their lives for this important right. Please contact your representatives on the Cuthbert City Council, Shellman City Council, and Randolph County Board of Commissioners to ask them to STOP this plan.

# **Proposed Poll Consolidation** presented to Voters

Consultant recommends consolidating from nine to two Precincts

Advertised Public Hearings took place in Randolph County on Thursday and Friday evenings last week, during which Mike Malone, consultant, presented the reasons and recommendations to consolidate polling precincts in Randolph County into two, Cuthbert and Shellman where the public meetings were held. Malone's presentation was aided by Power Point visual slides as he began explaining that the County Board of Commissioners (BOC) and by the Board of Elections and Registration (BER) had asked him to make recommendations. Malone has attended two elections and visited all of the polling locations.

The first consideration presented was compliance with American with Disabilities Act (ADA) Georgia Election Code sections 21-2 - 265 (d) and (e) and the SEB Rule 183-1-6-04. Malone stated that Randolph County is asked every Election Cycle to verify that all voting locations are acceptable for and adhere to ADA compliance. Of the nine precincts in Randolph County, only two are fully acceptable: Cuthbert and Shellman. All the other seven not acceptable. pho-Malone had tos of some of the ADA non-compliant issues which included doorways too narrow for wheelchairs, no handrails in bathrooms, no parking, no walkway, no ramps... and a health issue in itself: black mold on the walls of one of the polling precincts' bathrooms. In a fire station precinct, the polls would need to temporarily close if they should have to respond to a fire. At the Cuthbert (former) Middle School precinct, an open electrical box was observed and water fountain open to its plumbing

as well, ceiling tiles are missing or hanging (note: this location is no longer a Middle School). One slide stated "We need all the voting locations to be safe, accessible and temperature controlled to all voters of Randolph County, not for just some voters.


Chief Poll Manager Greg Holmes stated in the Shellman meeting that at the (seven) precincts there is no heat and no cooling; they are not climate controlled. Holmes said the Middle School roof leaks and some places didn't have running water, but the county was working on the water.

Budget and finances were, of course, a consideration in the recommendation to consider consolidating polling locations. In raw numbers of just election day personnel, there would be a savings of up to, or more than, \$7,000 for each closed precinct, as the requirement is to have three poll workers at each location from 7 a.m. – 7 p.m. each election day. This savings does not include the cost of voting machines and logic and accuracy testing. Malone stated, "This is your money (the tax payers)." In a year of primaries, runoff elections and general elections - it adds up.

To the accusation of

disenfranchising voters, Malone says nothing is farther from the truth. There is Advance voting By Mail (ABM) (also known as absentee ballots) for 45 days prior to an election; Advance voting In Person (AIP) which is 16 days of early voting Mon. - Fri. 8 a.m.-5 p.m. with one Saturday included. Malone had graphs tracking the votes in elections back to 2014, showing how many votes ABM, AIP and Polling (poll location) for all nine of the current Randolph precincts. He further stated that early voting, AIP,

is taking over in counties that have previously consolidated polling locations. Those counties in Georgia are: Bibb, Charlton, Evans, Greene, Lowndes, Morgan, Muscogee, Telfair, Tift and Webster.

Those seven locations to be closed / consolidated and the number of **active**  are as follows: Carnegie - 325 Cuthbert Middle School -321 Coleman - 206 Springvale - 237 Benevolence - 354 Fountain Bridge - 72 4th District - 103

**voters** in each precinct The recommendation:

~ Carnegie, Coleman, Cuthbert Middle School, Springvale and part of Benevolence to be consolidated into Cuthbert Courthouse polling location.

~ 4<sup>th</sup> District, Fountain Bridge and part of Benevolence be consolidated into Shellman.

The locations of Cuthbert and Shellman are well known, large enough, are ADA compliant and have adequate parking and infrastructure facilities to handle all



necessary equipment and voting functions.

The distances between each of the seven poll sites and the new consolidated location were also given:

### **To Cuthbert**

Carnegie – 9 miles Coleman – 10.3 miles Cuthbert Middle School – eight-tenths of a mile (.8) Springvale – 8.3 miles Benevolence – 9.1 mile

### **To Shellman**

4<sup>th</sup> District – 7.9 miles Fountain Bridge – 6.5 miles Benevolence to Shellman

- 15.3 miles

Malone stated that with consolidation, Election Management would be greatly enhanced with improved reaction time to special voter situations (such as voter confusion, out of precinct provisional ballots, absentee ballot issues); ADA compliance would not be an issue; delivery of voting equipment to the various polling locations would be minimized as it would eliminate the damage to voting equipment that is now taking place due to transportation to and from the sites on election days; and election results would be faster for candidates and the media.

Malone was hired by the County this past spring when the former Election Superintendent resigned abruptly at the end of March. Malone's name was supplied by other Election Superintendents who happened to be in training at the Secretary of State's (SOS) office, the day the call came for Randolph County asking for names of who they might contact. Malone's name was supplied along with two others via SOS staff.

At that time, Randolph BER was in dire need of an Election Superintendent to ensure the upcoming election ran properly. The May 22, 2018 election was rapidly approaching with deadlines for military ballots to be mailed along with other work to ensure all criteria for the election were met and the election conducted. The former Election Superintendent of Greene County, Malone was hired to fill in as superintendent until a permanent replacement could be hired. As the relationship with Malone progressed, he was asked to make recommendations and became a consultant to the County and BER.

# Senators Isakson, Perdue ask Army for Plan to address Dangerous Lead Levels

# Seek answers following recent report regarding on-base housing, including at Georgia's Fort Benning

WASHINGTON, D.C. - U.S. Senators Johnny Isakson (R-GA) and David Perdue (R-GA) today sent a letter along with Senators Tim Kaine (D-VA) and Mark Warner (D-VA) to the secretary of the U.S. Army raising concerns over a recent report about lead poisonings and dangerous lead levels in housing on U.S. Army installations, including Fort Benning, Georgia, which are endangering military families.

"We write to you today concerned about recent reports of lead poisoning at a number of Army installations. The health and safety of our service members and their families are of the utmost importance," the senators wrote. While the sale of lead-based paint is banned in the United States, many older homes still have the old paint on walls, which can become dangerous to children as it peels and chips. Young children are most susceptible to lead poisoning and face long-term developmental delays.

The report highlights cases of lead poisoning at on-base housing at Fort Benning, Georgia, Fort Knox, Kentucky, Fort Polk, Louisiana, Fort Bliss, Texas, Fort Hood, Texas, and a 2015 Department of Defense Inspector General report that found lead paint hazards at Fort Belvoir, Virginia. In the letter, the senators ask Army Secretary Mark Esper to provide a detailed briefing about what the Army is doing to keep military families safe and what they need from Congress to address this problem.

"We ask that you provide our offices with a detailed briefing as soon as possible outlining the immediate and longterm mitigation strategy to keep military families safe, provide medical treatment for those potentially or previously affected, make long-lasting repairs, and finally, provide legislative proposals or guidance on legislation needed to hold maintenance contractors accountable," the senators concluded.

## Congressman Sanford Bishop Statement in strong opposition to Voter Suppression efforts in Randolph County

**ALBANY, GA** (Mon., Aug. 20, 2018) – Congressman Sanford D. Bishop, Jr. (GA-02) released the following statement regarding the proposal by the election board of Randolph County, Georgia to close seven of the nine polling stations in Randolph County. Congressman Bishop represents Georgia's 2<sup>nd</sup> Congressional District, which includes Randolph County, as well as a significant portion of Middle and Southwest Georgia.

"I am outraged by the proposal to close seven of the nine polling stations in Randolph County and will do everything in my power to stop this act of voter suppression. The right to vote is fundamental to our system of government. This action would certainly work to disenfranchise voters in Randolph County, particularly Afri-



can American voters. It is a disgrace to our democratic process, and it is unacceptable. I will be reaching out today to the U.S. Department of Justice and the Georgia Secretary of State to express my strong opposition to these proposed voting station closures.

# **Rep. Greene opposes Local Proposal to close Polling Sites**

ATLANTA (Mon., Aug. 20, 2018) – State Representative Gerald Greene (R-Cuthbert) today announced his opposition to a proposal by the Randolph County Board of Elections and Registration to close polling sites in Randolph County.

"As I stated at the meeting last Thursday, I vehemently oppose this proposal to close seven polling sites, and I call on the Board of Elections to withdraw this proposal," said Rep. Greene. "During my time in office, I have sought to vigorously protect every citizen's right to vote. Closing seven of the nine polling locations in Randolph County would disenfranchise many of my constituents and restrict them from exercising their constitutional right to vote. I hope our county elections officials will do the right thing and keep these polling sites



open for the November elections."

Randolph County officials have proposed to close seven out of nine polling places for the November election that were open during this year's primary and runoff contests. The board of elections is set to vote on the proposal on August, 24, 2018.
